Privacy Policy for Rhema Canada and its Subsidaries

Last updated: July 21, 2021

This Privacy Policy describes Our policies and procedures on the collection, use, and disclosure of Your information when You use Our Services and tells You about Your privacy rights and how the law protects You.

We use Your data to provide and improve Our Services. By using our Service, You agree to the collection and use of information under this Privacy Policy. This Privacy Policy has been created with the help of the *Privacy Policy Generator*.

INTERPRETATION AND DEFINITIONS

Interpretation

The words in which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or plural.

Definitions

For this Privacy Policy:

- Account means a unique account created for You to access our Service or parts of our Service.
- **Company** (referred to as either "the Company," "We," "Us," or "Our" in this Agreement) refers to Rhema Christian Ministries, 49-40 Carl Hall Road.
- **Cookies** are small files that are placed on Your computer, mobile device, or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- Country refers to Ontario, Canada
- **Device** means any device that can access the Service such as a computer, a cellphone, or a digital tablet.
- **Personal Data** is any information that relates to an identified or identifiable individual.

- **Service Provider** means any natural or legal person who processes the data on behalf of the Company. - **You** refers to the individual accessing or using Our Service, or the company, or other legal entity on behalf of which such individual is accessing or using Our Service, as applicable.

TYPES OF DATA COLLECTED

Personal Data

While using Our Service, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally, identifiable information may include, but is not limited to:

Usage Data

Usage Data is collected automatically when using Our Service.

When You access the Service by or through a mobile device, We may collect certain information automatically, including, but not limited to, the type of mobile device You use, Your mobile device unique ID, the IP address of Your mobile device, Your mobile operating system, the type of mobile Internet browser You use, unique device identifiers and other diagnostic data.

We may also collect information that Your browser sends whenever You visit our Service or when You access the Service by or through a mobile device.

USE OF YOUR PERSONAL DATA

Law enforcement

TRACKING TECHNOLOGIES AND COOKIES

Rhema Christian Ministries collects and uses the information contained within an automatically created log of traffic on our website. JavaScript, cookies, and other tracking codes are included in all pages on our websites for use with Google Analytics. We use this information in a combined form to calculate overall site traffic patterns, analyze user trends, and administer the website.

We use Cookies and similar tracking technologies to track the activity on Our Service and store certain information. Tracking technologies used are beacons, tags, and scripts to collect and track information and to improve and analyze Our Service. The technologies We use may include:

- Cookies or Browser Cookies A cookie is a small file placed on Your Device. You can instruct Your browser to refuse all Cookies or to indicate when a Cookie is being sent.
